VENDOR FEE: \$40 PER TABLE (EACH TABLE COMES WITH 2 CHAIRS)

TABLE SIZE: TABLES ARE 6FT & 8FT (TABLE CLOTHS ARE NOT PROVIDED. PLEASE PREPARE TO HAVE A 6FT OR 8FT TABLE. WE RECEIVE OUR TABLES FROM THE VILLAGE THE DAY BEFORE, WE WILL NOT KNOW HOW MANY OF EACH TABLE WE GET.

ELECTRICITY: NO ELECTRICAL CONNECTIONS ARE GUARENTEED. YOU WILL BE NOTIFIED IF YOU ARE PLACED NEAR AN ELECTRICAL OUTLET AND YOU WILL BE RESPONSIBLE FOR PROVIDING AN EXTENSION CORD FOR YOUR SPACE.

SET UP/TAKE DOWN: SET UP BEGINS SAT, DEC 12TH AT 9AM. TAKE DOWN WILL BEGIN SAT, DEC 12TH AT 2PM. NOTHING CAN ARRIVE EARLY OR BE PICKED UP LATE!

SELLER REQUIREMENTS: YOU MUST BE SELLING ORIGINAL WORK! NO PREVIOUSLY USED ITEMS FOR RESALE ARE ALLOWED. THIS IS NOT A GARAGE SALE! IF CRWC EMPLOYEES DEEM YOUR ITEMS ARE NOT MEANT FOR THE MARKET, YOU WILL BE ASKED TO LEAVE WITHOUT REFUND.

REFUNDS: NO REFUNDS WILL BE GIVEN AFTER PAYMENT HAS BEEN MADE!

REGISTRATION DETAILS: REGISTRATION TAKES PLACE ONLY IN PERSON AT THE CRESTWOOD RECREATION AND WELLNESS CENTER. NO ONLINE OR OVER THE PHONE PAYMENTS ARE ACCEPTED. REGISTRATION WILL BE OPEN UNTIL MON, DEC 7TH OR UNTIL SPACES SELL OUT.
